

# PECATONICA SESQUICENTENNIAL PAGEANT

## RULES AND REGULATIONS

- ❖ Such term as “Applicant” used in these rules and regulations are referring to the person applying for entrance into the Pageant
- ❖ Such term as “Winner” used in these rules and regulations are referring to the person who has applied for entrance, paid the fee, was accepted as the participant, and won their division
- ❖ Applicant must reside in the township of Pecatonica, Illinois or reside in the Pecatonica, IL School District
- ❖ Applicant understands that he/she must complete in her age group: Sr. Mrs. or Ms. Pecatonica Sesquicentennial

Sr. Mrs. (60+ married, divorced, widowed),

Ms. (30+ married, unmarried, divorced, widowed),

Mrs. PS (20+ married),

Miss PS (20-29 never married nor given birth to a child)

Miss Teen (15-19 never married nor given birth to a child),

Jr. Miss Teen PS (8-14 never married nor given birth to a child),

Little Miss PS (ages 4-8)

Little Mister PS (ages 4-8)

Mr. and Mrs. (Married couple)

- ❖ Applicant understands that the ENTRY FEE in the amount of **\$35** must be paid with the submission of the Pageant Application
- ❖ Applicant understands that the ENTRY FEE is non-refundable and non-transferrable: and must be paid in full before he/she can compete in the Pageant
- ❖ Applicant understands that her entry fee includes entry into the pageant, cost of division crown, and sash
- ❖ Applicant understands that he/she must complete in three main areas of competition to be selected as a Pageant Winner; which includes **Interview (on-stage) Questions, Essay/Speech about Pecatonica, and a Photogenic competition**
- ❖ Applicant understands that he/she must submit the required materials and information for the appropriate competitions (Essay and Photogenic head-shot)
- ❖ Applicant understands that he/she must uphold a pleasant, professional, and friendly demeanor at all-times while representing a Pageant title
- ❖ Applicant understands that the judges’ decisions and scoring are final and will not be changed. The names of the judges will NOT be released prior to pageant day
- ❖ If the Applicant becomes a pageant title winner, he/she understands that he/she will receive the following: rhinestone crown, satin embroidered sash and flowers

- ❖ Winner grants permission to the Pageant to use her speeches, photographs, and videos in pageant related media for promotional purposes
- ❖ Applicant understands that the Pageant and the Pecatonica Sesquicentennial board reserves the right to add, change, or delete any rules and regulations at the time without giving notice
- ❖ Applicant is required to strictly adhere to the Pageant rules and regulations; and if any of these rules are broken by the applicant, applicant understands that participation disqualification and title revocation will be the resulting resolution to the matter
- ❖ For each age category to proceed there must be a minimum number of **3-5** applicants
