ORDINANCE 2011-12

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE VILLAGE OF PECATONICA IN THE COUNTY OF WINNEBAGO AND STATE OF ILLINOIS FOR 2011-2012

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF PECATONICA, COUNTY OF WINNEBAGO, STATE OF ILLINOIS, as follows:

SECTION 1. That the total amount of appropriations for all corporate purposes, legally made, to be collected from the tax levy of the current fiscal year is hereby determined to be the sum of One Hundred Twenty Five Thousand Five Hundred and Sixty Dollars and no cents (\$125,560.00).

SECTION 2. That the One Hundred Twenty Five Thousand Five Hundred and Sixty Dollars and no cents (\$125,560.00), being the total of appropriations which are to be collected from the tax levy of the current fiscal year of the Village of Pecatonica, are for the following purposes: Corporate, Police Protection, Street and Bridge, IMRF, Social Security and the Sewage Treatment Plant. The appropriations were made by ordinance passed and approved July 19, 2011 and published July 19, 2011.

The sum of One Hundred Twenty Five Thousand Five Hundred and Sixty Dollars and no cents (\$125,560.00) is hereby levied and subject to taxation for the current year. The specific amounts levied and assessed are as follows:

**A. Corporate Tax Levy (65 ILCS 5/8-3-1) Cap: .25%**

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for General Administration and Corporate purposes the sum of \$35,860.00, as set forth as follows:

Corporate Tax Levy \$35,860.00

**B. Police Protection Tax Levy (65 ILCS 5/11-1-3) Cap: .075%**

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Public Safety and Police Protection purposes the sum of \$15,500.00, as set forth as follows:

Police Protection Tax Levy \$15,500.00

**C. Street and Bridge Tax Levy (65 ILCS 5/11-81-2) Cap: .10%**

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Street and Bridge Repair and Maintenance purposes the sum of \$17,200.00, as set forth as follows:

Street and Bridge Tax Levy \$17,200.00

**D. Illinois Municipal Retirement Fund (40 ILCS 5/7-171)**

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Municipality Contributions to Illinois Municipal Retirement Fund the sum of \$26,000.00, as set forth as follows:

Municipality Contributions to IMRF                      \$21,000.00

**E. Federal Social Security (40 ILCS 5/21-110)**

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Municipality Contributions to Federal Social Security the sum of \$20,000.00, as set forth as follows:

Municipality Contributions to Federal Social Security                      \$20,000.00

**F. Sewage Treatment Plant (65 ILCS 5/11-142-1)**

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for the Municipality Sewage Treatment Plant the sum of \$16,000.00, as set forth as follows:

Sewage Treatment Plant                      \$16,000.00

**SECTION 3.** That the summary of the levies made in this Ordinance are the following:

A.	Corporate Fund Property Tax	\$35,860.00
B.	Police Protection Tax	\$15,500.00
C.	Street and Bridge Tax	\$17,200.00
D.	Municipality Contributions to I.M.R.F.	\$21,000.00
E.	Municipality Contributions to Federal Social Security	\$20,000.00
F.	Sewage Treatment Plant	\$16,000.00
	<b>TOTAL</b>	<b>\$125,560.00</b>

**SECTION 4.** That the total amount, One Hundred Twenty Five Thousand Five Hundred and Sixty Dollars and no cents (\$125,560.00) as specified above, is hereby levied and assessed against all property subject to taxation within the Village of Pecatonica according to the value of said property as assessed and equalized for state and county purposes for the current year.

**SECTION 5.** This Levy Ordinance is adopted pursuant to the procedure set forth in the Illinois Municipal Code and the Illinois Revenue Code.

**SECTION 6.** That there is hereby certified to the County Clerk of Winnebago County, Illinois the preceding sums, totaling One Hundred Twenty Five Thousand Five Hundred and Sixty Dollars and no cents (\$125,560.00), which amount is required to be raised by taxation for the current fiscal year of the Village of Pecatonica for which the Clerk of the Village is hereby ordered to file with the County Clerk of Winnebago County, on or before the time required by law, a certified copy of this Ordinance.

**SECTION 7.** That all orders, resolutions, or ordinances in conflict herewith are hereby repealed insofar as such conflict exists and this Ordinance shall take effect immediately upon its passage, approval and publication as provided by law.
