## Ordinance 2012-04

## PREVAILING WAGE ACT ORDINANCE

WHEREAS, the State of Illinois has enacted, "An Act Regulating Wages of Laborers, Mechanics and Other Workers Employed in any Public Works by the State, County, City or any Political Subdivision or by Anyone under Contract for Public Works", approved June 26, 1941, codified as amended, 820 ILCS 130/1 et seq. (1993), formerly III. Rev. Stat., Ch. 48, par. 39s-1 et seq. and

WHEREAS, the aforesaid Act requires that the Board of Trustees of the Village of Pecatonica investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Village of Pecatonica employed in performing construction of public works, for said Village.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF PECATONICA:

Section 1. To the extent and as required by "An Act Regulating Wages of Laborers, Mechanics and Other Workers Employed in any Public Works by the State, County, City or any Public Body or any Political Subdivision or by Anyone under Contract for Public Works", approved June 26, 1941, as amended, the general prevailing rate of wages in this locality of laborers, mechanics, and other workers engaged in construction of public works coming under the jurisdiction of the Village of Pecatonica is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Winnebago County area as determined by the Department of Labor of the State of Illinois as of May 2012 (Exhibit "A"), copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the Department's June determination and apply to any and all public works construction undertaken by the Village of Pecatonica. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

Section 2. Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village of Pecatonica to the extent required by the aforesaid Act.

Section 3. The Village of Pecatonica shall publicly post or keep available for inspection by any interested party in the main office of the Village this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

Section 4. The Village of Pecatonica shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

Section 5. The Village of Pecatonica shall promptly file a certified copy of this Ordinance with both the Secretary of State, Index Division, 111 East Monroe St. Springfield, IL 62756 and the Department of Labor of the State of Illinois Conciliation and Mediation Div. #1 West Old Capital Plaza Room 300 Springfield, IL 62701-1217.

Section 6. The Village of Pecatonica shall cause a notice to be published in a newspaper of general circulation within the area that the Notice of Determination of such prevailing rate of wages, stating that a copy of this Ordinance so determining the prevailing rate of wages is available for public inspection by any interested person at the Office of the Village Clerk, Village Hall, 405 Main Street, Pecatonica, Illinois 61063.

Section 7: This Ordinance shall be in full force and effect from and after its passage as provided by law. This Ordinance shall be published in pamphlet form.
