**ORDINANCE NO. 2015 - 01**

**AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE VILLAGE OF PECAONICA, WINNEBAGO COUNTY, ILLINOIS PROVIDING FOR AND REQUIRING THE SUBMISSION OF A PROPOSITION TO FUND EXPENDITURES FOR GENERAL CORPORATE PURPOSES WITHIN THE VILLAGE VIA AN INCREASE IN THE GENERAL CORPORATE TAX FROM 0.1143 PERCENT TO 0.4375 PERCENT OF ALL THE TAXABLE PROPERTY WITHIN THE VILLAGE AT THE CONSOLIDATED ELECTION TO BE HELD ON APRIL 7, 2015**

**WHEREAS**, the Board of Trustees for the Village of Pecatonica, Winnebago County, Illinois (“Municipality”) deems it advisable and in the best interest of the Municipality and its residents to provide fully adequate municipal services within the Village; and

**WHEREAS**, the Municipality hereby finds and determines that the current financing for general corporate purposes within the Municipality via a 0.1143% tax of all the taxable property within the municipality is no longer sufficient to generate the funds needed to provide adequate municipal services within the Municipality; and

**WHEREAS**, the Municipality has determined that it is necessary to increase the currently assessed tax rate of 0.1143% of all taxable property within the Municipality for general corporate purposes to 0.4375% of all taxable property within the Municipality in order to adequately fund municipal services within the Municipality; and

**WHEREAS**, the Municipality hereby finds and determines that it is advisable, necessary and in the best interest of the Municipality that the proposition to fund expenditures for general corporate purposes via an increase in the general corporate tax levy rate from 0.1143% to 0.4375% of all taxable property within the Village pursuant to 65 ILCS 5/8-3-1 be submitted to the voters of the Municipality at an election to be held and conducted in accordance with the General Election Laws:

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees for the Village of Pecatonica, Illinois, Winnebago County, Illinois as follows:

**SECTION ONE**

1. Recitals. That the Municipality hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and does incorporate them into this Ordinance by reference. The Municipality further finds that as of the date of the adoption of this Ordinance, the most recent levy year for which the limiting rate of the entire Municipality is known as 2014.
2. Increase in Tax. It is hereby necessary and in the best interests of the Municipality that the proposition to fund expenditures for general corporate purposes via an increase in the general corporate tax levy rate from 0.1143% to 0.4375% of all taxable property within the Village pursuant to 65 ILCS 5/8-3-1 be submitted to the voters of the Municipality.
3. Submission of Question. That the proposition referred to above be submitted to the voters of the Municipality in accordance with the General Election Law at the Consolidated Election to be held on Tuesday, the seventh day of April, 2015, during the hours provided by law for voting on such day (“Election”).
4. Judges, Precincts and Polling Places. The judges, precincts and polling places for the Election on the question shall be those appointed and established for the Election within the Municipality by the Electoral Board of the Village (“Election Authority”), all as provided by the General Election Law.
5. Notice of Election. Notice of the public question to be submitted at the Election shall be given as set forth in this Section. Not more than thirty (30) days nor less than ten

(10) days before the date of the election, the Election Authority shall publish notice of the Election in a local community newspaper having general circulation in the Village. The Notice shall also be given at least ten (10) days before the date of the Election by posting a copy of the notice at the principal office of the Election Authority. The Village Clerk shall also post a copy of the notice at Village Hall.

6. Newspaper. It is hereby found and determined that *The Gazette* is a local, community newspaper published in and having a general circulation within the Municipality, as required by Sections 12-4 and 12-5 of the Election Code of the State of Illinois, as amended.
7. Form of Notice. That, subject to modification to comply with the Election Code, the notice of the election shall include substantially the following:

NOTICE IS HEREBY GIVEN that at the Consolidated Election to be held on Tuesday, the seventh day of April, 2015, the following proposition will be submitted to the voters of the Village of Pecatonica, Winnebago County, Illinois:

“SHALL THE VILLAGE OF PECATONICA, ILLINOIS, FOR EXPENDITURE FOR GENERAL CORPORATE PURPOSES WITHIN THE VILLAGE INCREASE THE GENERAL CORPORATE TAX RATE FROM 0.1143 PERCENT TO 0.4375 PERCENT OF ALL TAXABLE PROPERTY WITHIN THE VILLAGE PURSUANT TO 65 ILCS 5/8-3-1?”

(1) The approximate amount of taxes extendable at the most recently extended limiting rate is \$110,391.60, and the approximate amount of taxes extendable if the proposition is approved is \$198,530.34.

(2) For the 2014-2015 levy year the approximate amount of the additional tax extendable against property containing a single family residence and having a fair market value at the time of the referendum of \$100,000 is estimated to be \$107.72.

The polls at such Election will be open at 6:00 a.m. and continue to stay open until 7:00 p.m. of that day.

**SECTION THREE**

**Electronic Voting**

That, if an electronic voting system is used in the Village, the Election Authority shall publish, not less than five (5) days prior to the Election, a true and legible copy of this Specimen Ballot containing the questions to be voted upon at the Election in two (2) or more newspapers published in and having general circulation within the Village.

## **SECTION FOUR**

### **Judges**

That the Election shall be conducted by Election Judges appointed by the Election Authority to act in the precincts at which the proposition will be submitted to the voters in the Municipality.

## **SECTION FIVE**

### **Certified Election Authority**

That after the adoption of this Ordinance not less than sixty-one (61) days prior to the Election, the Village Clerk shall certify a copy hereof to the Election Authority in order that the proposition set forth herein may be submitted to the voters of the Municipality at the Election. A copy of the certification shall be in substantially similar form of Exhibit A attached hereto and incorporated herein.

## **SECTION SIX**

### **Canvass**

That the Election shall be held and conducted and the returns thereof duly canvassed, all in the manner and time provided by the General Election Law.

## **SECTION SEVEN**

### **Conflict**

That all Ordinances, Orders and Resolutions and parts thereof in conflict herewith be and the same hereby are repealed, and this Ordinance shall be in full force and effect upon its

adoption and that this Ordinance in any event shall be deemed to be subject to modification and application to comply with the General Election Law.
